

Rules for Gingerbread House Contest

Dec. 1, 2018

Gingerbread house must be completely made of edible products.

Size parameters are established by the need to be able to get the houses once constructed through a 32-inch wide door of the building where they will be displayed and each entry must be submitted on a cardboard, wooden or plastic base and must be larger than the house.

Divisions of competition will include:

- A.) Age 12 and under
- B.) Age 13 and over

Cash prizes will be awarded in each of the amateur divisions.

The entries must be delivered to the Kingsburg Council Chambers, 1401 Draper Street in Kingsburg no earlier than 9 a.m., Friday, November 30 and no later than 5 p.m. that same day.

The entries will remain the possession of the entrant, though they will be on display until the conclusion of the Santa Lucia Celebration, Saturday, Dec. 2. The entries must be claimed by no later than 3 p.m. Dec. 5 (unless special arrangements are made ahead of time).

Entries will be judged by an independent panel based upon their uniqueness and attention to detail and quality of presentation.

Deadline to submit an entry form is November 30th, 5 p.m.
